The penal law of the imperial period-from roughly 200 B.C. to 1911 A.D.-is of particular interest, although little known or studied in the West, because each of the great dynasties produced codes which functioned both as instruments of government and as a means for the enforcement of Confucian morality. The content of the codes-untouched by Western influences-remained on many important topics largely unchanged from at least the seventh to the twentieth century.
